Sir,

I am to state that the Council at its meeting held on 29.10.98 considered the matter with regard to recognition of Jawahar Medical Foundation's ACPM Medical College, Dhule for the award of MBBS degree granted by Poona University/North Maharashtra University, Jalgaon. The Council approved the following recommendations of the Executive Committee which I am directed to convey herewith for your information and necessary action:-

"The Executive Committee noted that the compliance verification report (March, 98) on the defects and deficiencies pointed out in the previous inspection report was considered by the Committee at its meeting held on 2.7.98 wherein the Committee had decided to advise the authorities to rectify certain deficiencies noted by it.

The Committee further noted that the compliance received in response to this decision communicated to the college authorities on 15.7.98 has been verified by way of an inspection held on 6th & 7th August, 98. On deliberation on the inspection report, the Committee noted that the available clinical material along with the staff and other infrastructural facilities are now adequate for 100 admissions.

In view of the above observations, the Executive Committee decided to recommend that Jawahar Medical Foundation's ACPM Medical College, Dhule be recognised for the award of MBBS

degree granted by Poona University and North Maharashtra University, Jalgaon with 100 annual admissions."

The first batch of the students admitted against JMF's ACPM Medical College, Dhule appeared in the final MBBS examination held by Pune University in November, 1994. The MBBS degree of Pune University is already recognised and included in the first schedule to the I.M.C. Act, 1956. The second batch admitted against this college in the academic session 1991-92 appeared under North Maharashtra University, Jalgaon in November, 1995.

The MBBS degree granted by North Maharashtra University, Jalgaon has already been notified vide notification No.V.11015/19/94-ME(UG), dated 8.4.1997. However, the said notification is only in respect of students being trained at Bhausaheb Hire Govt. Medical College, Dhule. The Government is requested to issue notification regarding recognition of MBBS degree granted by North Maharashtra University, Jalgaon in respect of students being trained at JMF's ACPM Medical College, Dhule.

A copy of the inspection report (August, 1998) is enclosed herewith.
